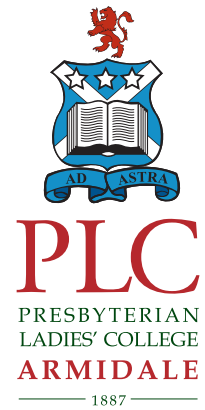


Senior Boarders Application Form PRIVATE MOTOR VEHICLE USE 2016



Senior Boarders (Years 11 & 12) Boarders may apply to have a private motor vehicle at school for personal use only with the permission of the Principal, Head of Boarding and their parents.

In seeking permission to have use of a private motor vehicle at the College, both Boarders and their Parents/Guardians must acknowledge and accept the following conditions.

CONDITIONS OF USE:

- A Boarder may only carry passengers with prior parental/guardian permission to be transported by the Boarder in their car.
- The Boarder must at all times adhere to the road and traffic rules.
- The Boarder must at all times follow the College rules pertaining to leaving the site.
- The Boarder may drive to external classes/sports/appointments as approved by the Head of Boarding.
- When not in use, the motor vehicle keys are to be left with the Boarding House staff.
- A copy of the student's Drivers License is to be supplied to the College
- The motor vehicle is to be road worthy and fully registered
- Evidence of comprehensive motor vehicle insurance policy cover is required if other students are to be transported by the Boarder.
- The motor vehicle is not to be loaned to, or driven by other students
- Parking within the grounds of the College must only be in the Crest Road Car Park behind the Boarding Houses.

Please provide names of students you approve to ride in the car with your daughter. Permission will be sought from those parents in order for the students to ride in the car.
